## Registration and attendees

Stakeholders were able to register via a link on the <a>SanteeCooper.com/IRP</a> webpage. The link led to a form on the Zoom platform. Registrants received an immediate confirmation email with meeting information, as well as two reminder emails: one week and one day, before the session respectively.

Santee Cooper used a variety of means to announce the meeting, in advance, to customers and stakeholders including newspaper advertisements, bill inserts and social media.

Registration for the session opened on the first week of February 2022.

- 210 registrations received prior to the start of the meeting on March 1, 2022
- 127 individuals were online for all, or a portion, of the meeting
- About 75% of those who attended, identified an organization affiliation during registration

### **Q&A Summary**

Stakeholders were able to include questions and comments when registering for the March 1<sup>st</sup> meeting. The questions, comments and stated positions received from stakeholders during the registration process were reviewed and helped to inform the preparation for the session. See Appendix B for questions, comments and stated positions received during the registration process (and are quoted verbatim for the sake of accuracy).

During the March 1<sup>st</sup> meeting, stakeholders were able to ask questions in two ways:

- 1. Using the Zoom Q&A tool where they could type and send a question at any time during the session and presentations; and
- 2. Using the *Raised Hand* functionality where they would be invited to speak by the facilitator at the earliest opening

Santee Cooper and the facilitators left blocks of time (~30 minutes each) where Stakeholders were invited to ask questions live prior to breaking for lunch and again prior to the end of the meeting. During these blocks, there were several typed questions that were answered in writing by subject matter experts directly in the Q&A tool. Some questions were flagged and answered live in the session. A few stakeholders chose to ask questions or make comments live throughout the day, particularly in the blocks specifically set aside for open interactions.

Overall, there were 96 interactions (live asked/answered and written asked/answered), all of which were addressed during the session. Of these, 12 questions included follow-on questions often coming from more than one stakeholder, indicating that the stakeholders were monitoring and interacting with each other's questions. 10 questions were answered live by presenters.
