### Meeting Information & Materials

Santee Cooper convened the first meeting of the Integrated Resource Plan (IRP) Stakeholder Working Group on Thursday, April 25, 2024. The formation of the IRP Stakeholder Working Group (or working group) is an integral part of Santee Cooper's commitment to creating a robust Integrated Resource Planning (IRP) process and to continually engage stakeholders to solicit feedback.

### Session Participation

The Stakeholder Working Group has a set membership of organizations and individuals representing diverse interests and perspectives including government, regulatory agencies, environmental, social, customer classes, etc. Each organization was invited to join the working group by the Santee Cooper team and asked to assign a primary and secondary member. ### Topics, Presenters and Discussion

#### Welcome

– *Rahul Dembla, Chief Planning Officer, Santee Cooper*

Rahul Dembla welcomed all those attending and expressed appreciation for the investment of time and resources for the many in attendance who also participated and intervened in Santee Cooper's 2023 IRP process. Rahul then reviewed the 2023 IRP process and Santee Cooper's preferred portfolio.

Stewart Ramsay introduced the core group of people involved in the working group for Santee Cooper:

All members in attendance were asked to introduce themselves and share their name, organization, role, and prior IRP experience. Members were also encouraged to turn on their cameras and leave them on throughout the session.

A review of the agenda and meeting outcomes followed introductions. The two key outcomes were to have:

1. successfully launched the working group, including confirming that members understood the commitment required of them to participate, the commitments required of Santee Cooper from the 2023 IRP and that members had the opportunity to provide input on priority topics for future meetings; and
2. members provide feedback on the current Santee Cooper load forecast updates.

### **Member Discussion of the Working Group**

– *Clay Settle, Manager Resource Planning, Santee Cooper*

Clay Settle touched on key elements of the working group charter, specifically the mission, objectives, in- and out-of-scope topics and proposed working group logistics. Questions and discussion focused largely on what may be in- and out-of-scope for working group meetings.

### **Stakeholder Engagement Plan**

– *Jane Campbell, Senior Director Resource Planning, Santee Cooper*

Jane Campbell provided an overview of the IRP stakeholder engagement plans through Santee Cooper's next filing of its Triennial IRP in September of 2026. Jane welcomed feedback based on members' participation in other IRP processes and working groups. Discussion touched on the openness and collaboration of the IRP process and the value for all members and resource planning to share varying opinions.

### **Santee Cooper Resource Planning Update**

– *Rahul Dembla, Chief Planning Officer, Santee Cooper*

Rahul Dembla covered Santee Cooper's current and future IRP planning initiatives and discussed the intersection of statutory obligations, the Coordination Agreement with Central and PSC approval requirements.

### **2023 IRP Public Service Commission Order and Short-Term Action Plan**

– *Clay Settle, Manager Resource Planning, Santee Cooper*

Clay Settle presented the requirements from the 2023 IRP PSC Order<sup>2</sup> and then provided an overview of Santee Cooper's short-term action plan from the 2023 IRP. Discussion covered a wide range of topics including the retirement of coal units, transmission planning analysis, deployment of carbon-free resources, compliance with EPA 111 rule and more.

### **Priority Topics for the Working Group**

– *Clay Settle, Manager Resource Planning, Santee Cooper*

Clay Settle presented to members a proposed agenda for the next working group meeting, tentatively scheduled for late-June, which included assumptions and portfolios for the 2024 Annual IRP Update. Clay

continued by providing an overview of proposed priority topics for future working group meetings. Discussion related to the priority topics acknowledged the need for continuous updates to the list and review at each working group meeting as circumstances evolve.

**Technical Presentation on Load Forecast Methodology**

Greg McCormack and Carl Ciullo discussed the status and plans for Santee Cooper's current load forecast. Members discussed the complexity of load forecasting in a dynamic environment and conversation identified the need for a technical meeting.

Stewart Ramsay reviewed the action items captured during the meeting and confirmed them with members. Stewart committed Vanry to sending the summary out to members on or before May 7<sup>th</sup> and requested member feedback no later than May 17<sup>th</sup>.

Finally, Stewart checked with the group to assess how well the meeting objectives were met and invited members to fill out the five-question survey upon leaving the zoom meeting.
