

Terms & Conditions Free Share of Solar Share Contest

Contest

One lucky person that enters a drawing for Solar Share between April 1, 2021 thru April 30, 2021 will stand a chance to win one (1) kW Solar Share valued at \$1,540 less \$1,200 Rebate = Discounted Subscription Fee \$490 (the “Prize”). **Winner will be responsible for paying monthly DG Rider fees of \$4.40 stand-by fee and \$2.00 for meter fee.** *Estimated Annual Savings for 1 kW of Solar Share \$84.00.* The contest begins on April 1, 2021 and ends on April 30, 2021 at 11:59PM. Unless expressly stated within these terms and conditions, all other expenses related to the Prize are the responsibility of the winner.

Change Policy

Santee Cooper reserves the right to cancel the Free Share of Solar Share if customer is not willing to pay the extra monthly costs as stated above.

Proof of Purchase

Any Santee Cooper residential or commercial customer may register to win the Prize between April 1, 2021 and April 30, 2021. Purchase not required.

Who can Enter:

Santee Cooper Customers are eligible to participate in this competition if they are persons who are at least 18 years old or with parental or guardian consent.
